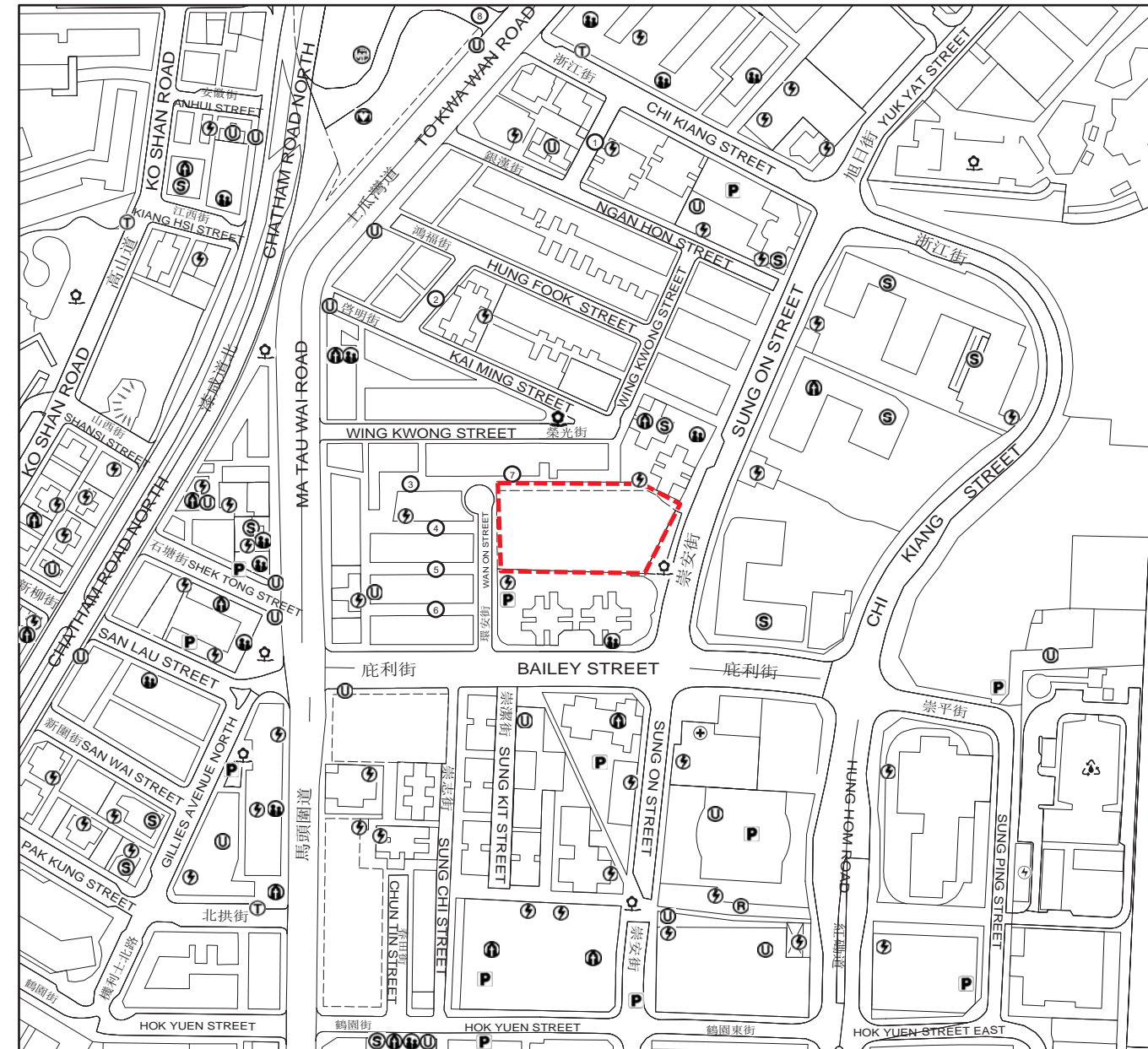


# LOCATION PLAN OF THE DEVELOPMENT
