The borrower(s) and/or guarantor(s) must provide the duplicate copies of their identity documents and all relevant supporting evidence as the Finance Company may think necessary. The documents provided will not be returned. All the borrower(s) and/or guarantor(s) must sign the relevant legal documents personally at the office of solicitors' firm designated by the Finance Company. **The Finance Company reserves its right to reject any attorney of the borrower/quarantor to sign any document (related to the Second Mortgage Loan) on behalf of the borrower/quarantor.**
