- Balloting in the manner as described below will be used to determine the order of priority for selection of specified residential properties on the First Date of Sale.

### **Part (I) : Registration**

#### **第(I)部分：登記**

1. All persons or companies (if the registrant is a company, then any one of its directors) must complete and return at most one Purchase Form distributed on the First Date of Sale and bring along the following **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend to 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Sales Office”)** from 10:00 a.m. to 10:30 a.m. on the First Date of Sale (“the check-in timeslot for registrants”):-

  - (a) relevant cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to select as indicated in the Purchase Form. Each cashier order shall be in the amount of HK\$100,000 and made payable to “DEACONS”, Please bring along blank cheque(s) for payment of balance of preliminary deposit(s) ;and

Card(s) or Passport(s) (as the case may be) of the director(s) of (each of) the registrant(s) (if the registrant(s) is/are company(ies)).

### **Part (II) : Balloting and selection of specified residential properties**

#### **第(II)部分：抽籤及揀選指明住宅物業**

2. The order of priority of selection of the specified residential properties on the First Date of Sale and for selecting and purchasing the specified residential properties will determine by balloting.

#### **a) Balloting**

## 抽籤

- i) The priority of the selection of specified residential properties among all registrants will be determined by way of balloting. The balloting for the registrants will commence at 10:30 a.m. at the Sales Office on the First Date of Sale. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting. Any changes to the time and date of the second round balloting will be posted at the Sales Office. The registrant(s) will not be separately notified of such changes.

所有已填妥購樓表格之登記人的揀選指明住宅物業的先後次序會以抽籤決定。抽籤程序將於出售首日上午十時半或之後於售樓處進行。為了維持售樓處秩序及／或流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整抽籤程序的時間和日期。任何抽籤程序的時間和日期的修改會張貼於售樓處。登記人將不獲另行通知該等修改。

- ii) The registrant(s) whose identity(ies) has/have been verified by the Vendor shall be allotted one lot. The registrant(s) who arrive at the Sales Office at any time later than “the check-in timeslot for registrants” shall not be eligible to participate in the Balloting. The results of the balloting, including registration number and “ballot result sequence” will be announced and/or posted by the Vendor at the Sales Office. The registrant(s) will not be separately notified of the ballot results.

## b) Unit Selection 揀樓

- i) Immediately after the balloting, the registrant(s) (if the registrant is a company, then any one of its directors) shall **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor** select the specified residential properties which are still available at the time of selection in the order of priority according to the “ballot result sequence” and in an orderly manner and within reasonable time. Registrant(s) may select and purchase **at least one (1) and at most two (2)** specified residential properties. If the number of specified residential properties a registrant selects and purchases is more than the number of cashiers’ order(s) submitted, the registrant shall submit on spot one cashiers’ order (of the payee and amount as stated in paragraph 1(a) above) in respect of each such extra specified residential property to settle part of the preliminary deposit of that extra specified residential property (the balance of the preliminary deposit to be paid by cheque(s)). Where it is the turn of a registrant to select specified residential property(ies) and that registrant fails to make such a selection (whether or not there does not remain a sufficient number of specified residential property(ies) for fulfilling such criteria), such registrant will cease to be eligible for selection of any specified residential properties in the Unit Selection.

於完成抽籤後，每個登記人（如登記人為公司，則該公司任何一位董事）須根據「抽籤結果順序」有秩序地及於合理時間內親臨或由其按賣方規定的格式並有效地簽署的授權書所委任的授權人於售樓處揀選當時仍可供揀選的指明住宅物業。登記人可揀選及購買至少 1 個及最多 2 個指明住宅物業。倘登記人揀選及購買的指明住宅物業數目多於其所遞交之銀行本票數目，登記人須就每一個超出之指明住宅物業即場補交一張銀行本票（抬頭人及金額如上文第 1(a)段所述者）以支付該超出之指明住宅物業的部份臨時訂金（臨時訂金之餘額以支票支付）。如輪到登記人揀選指明住宅物業時因任何原因未作出如此揀選（不論是否因為剩下可供揀選的指明住宅物業數目不足以符合該準則），則該登記人將被取消揀樓時段內揀選任何指明住宅物業之資格。

- ii) (If the registrant(s) is/are individual(s)) If only one specified residential property is selected, the purchaser of such selected specified residential property shall be that individual registrant with or without one or more close relative(s) of that individual registrant; If two specified residential properties are selected, the purchaser of one of such selected specified residential properties shall be that individual registrant with or without one or more close relative(s) of that individual registrant, and the purchaser of the other of such selected specified residential properties shall be: (1) that individual registrant (or any one or more persons comprising that registrant) with or without one or

more close relative(s) of that individual registrant; or (2) one or more close relative(s) of that individual registrant.

- iii) (If the registrant is a company) The purchaser of at least one such selected specified residential property shall be that company registrant, and the purchaser of the other of such selected specified residential property (if any) shall be: (1) that company registrant; or (2) a company which is incorporated in Hong Kong and any one director of which must be the same person as any one director of that company registrant.

- iv) If a registrant has made a selection of specified residential property(ies) as aforesaid, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said registrant has given up the right to select and purchase the specified residential property(ies) in Unit Selection. In such event, such registrant will not be eligible to select any of the specified residential properties in Unit Selection on the First Date of the Sale.

如登記人已按上文揀選指明住宅物業但因任何理由未能或拒絕簽署任何一個已揀選之指明住宅物業的臨時買賣合約，該登記人將被視作放棄在揀樓時段內揀選及購買指明住宅物業的權利。在這種情況下，該登記人將不能繼續於出售首日揀樓時段內揀選任何指明住宅物業。

3. A “close relative” of a registrant shall mean a spouse, parent, child, parent-in-law, child-in-law, grandparent, grandchild and sibling or any person comprising the registrant provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s). The Vendor’s determination as to whether there is such a relationship shall be final.

4. The Vendor reserves its right to adjust the time of selection of specified residential properties in accordance with the progress of confirmation and verification of identities of registrants or the carrying out of other procedures.

5. For the safety of the registrants and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in effect in Hong Kong or where the Vendor considers that there being an event affecting the safety or order in the Sales Office and/or the vicinity of any of foregoing, postpone, extend or modify the date, time, period, deadline or place of the submission of Registration of Intent or of any balloting, the check-in timeslot for registrants or selection of specified residential properties to such other date, time, period, deadline or place as the Vendor may consider appropriate. Details will be announced on the website of the Phase of the Development and registrants will not be separately notified of the same.

After the selection of specified residential properties by the registrant(s) as aforesaid have been completed, the remaining available specified residential properties will be offered to be sold on a first come first served basis. The Vendor does not accept any person interested in purchasing the specified residential properties having queued up

before the Time of the Sale on the date concerned.

7. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).

**On 27 October 2019 and thereafter**

First come first served. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).

Please refer to “Time of the Sale” in this document for the opening hours of the Sales Office. The Vendor does not accept any person interested in purchasing the specified residential properties having queued up before the Time of the Sale on the date concerned.

The Vendor reserves the right to close the Sales Office and Additional Designated Venue at any time if all the specified residential properties have been sold out. For the safety of the registrants and maintenance of order at the Sales Office and/or the Additional Designated Venue, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in effect in Hong Kong or where the Vendor considers that there being an event affecting the safety or order in the Sales Office, the Additional Designated Venue and/or the vicinity of any of foregoing, postpone or modify the date, time, period or place of sale to such other date, time, period or place as the Vendor may consider appropriate. Details will be announced on the website of the Phase of the Development and persons interested in purchasing the specified residential properties will not be separately notified of the same.
